## Advice for Child to Self-Isolate for 9 Days

Dear Parent/Guardian.

We have been made aware that we have a positive case of coronavirus (COVID-19) for a student within our Year 8 learning bubble at Oldbury Wells School (This case is not connected to the positive case in Year 11). The student is in the '8X half' of the year group; therefore, this letter is only for students in the following tutor Groups:

- 8JAK (Mr Kiapene)
- 8JMO (Mrs Moore)
- 8MBR (Miss Brindley)

We have followed the national guidance and discussed the detail with Shropshire's Public Health Team alongside Public Health England (PHE). As a result, we have made the decision to close the school for students in the three tutor groups identified. *In line with national guidance your child must stay at home and self-isolate with immediate effect until Monday 30<sup>th</sup> November.* They should return to school on Tuesday 1<sup>st</sup> December. (The dates provided for the period of isolation are advised by PHE based on the last point of possible contact in school). All students in the '8Y' Half of the year group should attend school as normal.

I am aware that the timing of this communication is difficult with it being the weekend, although our priority is to make sure that any communication received is shared at the earliest opportunity.

During this period of isolation, your child will be set work via distance learning and is expected to access work via Satchel One and Microsoft TEAMS, lessons will be delivered in line with their normal school timetable. Parents will receive further information regarding this tomorrow.

If your child has siblings in another year group at the school, as outlined in government guidance, they should attend school under normal arrangements.

If your child is well at the end of the period of self-isolation, then they can return to usual activities.

Other members of your household can continue normal activities provided your child does not develop symptoms within the 9 day self-isolation period. Please see the link to: Guidance for contacts of people with confirmed coronavirus (COVID-19) infection who do not live with the person:

Please leave your contact details and the name of your child within any communication.

## What to do if your child develops symptoms of COVID 19

If your child develops symptoms of COVID-19, they should remain at home for at least 10 days from the date when their symptoms appeared. Anyone with symptoms will be eligible for testing and this can be arranged via <a href="https://www.nhs.uk/ask-for-a-coronavirus-test">https://www.nhs.uk/ask-for-a-coronavirus-test</a> or by calling 119.

People who do not have symptoms should not request a test unless this has been specifically requested by Public Health England or the local authority.

All other household members who remain well must stay at home and not leave the house for 14 days. This includes anyone in your 'Support Bubble'. The 14-day period starts from the day when the first person in the house became ill.

Household members should not go to work, school or public areas and exercise should be taken within the home. If you require help with buying groceries, other shopping or picking up medication, or walking a dog, you should ask friends or family. Alternatively, you can order your shopping online and medication by phone or online. Household members staying at home for 9 days will greatly reduce the overall amount of infection the household could pass on to others in the community.

If you are able can, move any vulnerable individuals (such as the elderly and those with underlying health conditions) out of your home, to stay with friends or family for the duration of the home isolation period. # **Symptoms of COVID 19**

The most common symptoms of coronavirus (COVID-19) are recent onset of:

- new continuous cough and/or
- high temperature and/or
- a loss of, or change in, normal sense of taste or smell (anosmia)

### For most people, coronavirus (COVID-19) will be a mild illness.

# How to stop COVID-19 spreading

There are things you can do to help reduce the risk of you and anyone you live with getting ill with COVID-19. *Do:* 

- wash your hands with soap and water often do this for at least 20 seconds
- use hand sanitiser gel if soap and water are not available
- wash your hands as soon as you get home

- cover your mouth and nose with a tissue or your sleeve (not your hands) when you cough or sneeze
- put used tissues in the bin immediately and wash your hands afterwards
